Secretary:

- o Review minutes from the previous meeting
 - ✓ Jerry made motion to approve minutes; seconded by Ed; motion approved
- O Date & time for next meeting: March 1, 2021 at 6:30pm at Blackhawk

• Treasurer:

- Review the treasures report
 - ✓ Approximately \$175 cash on hand
 - ✓ Approximately \$10K decrease from 2020 to 2021
 - Largest expenses:
 - \$4100 for fence deposit
 - \$4700 targets
 - \$1330. insurance
 - ✓ Alan made motion to approve treasurers report; motion seconded by Ed; motion approved
- The necessary information has been sent to our accountant in order to File Form 990 nonprofit annual reporting return with the IRS.

Covid-19:

- O Dane County Health Covid-19 restrictions currently in effect under Emergency Order #12 effective on January 13, 2021 and scheduled to expire on February 10, 2021.
 - ✓ Limits indoor gatherings to 10 people with physical distancing and face coverings.
 - ✓ Indoor gyms, courts, swimming pools can operate at 50% capacity. Scheduled activities are limited to 10 or fewer people who do not live together.
 - ✓ Allows outdoor gatherings up to 50 people (not including employees) who are not from the same household. You must be physically distanced from anyone you don't live with.
 - ✓ Masks are required for most people 5 years of age and older when in an enclosed space with people you don't live with.
 - ✓ At restaurants, indoor dining capacity reduced to 25% of approved seating capacity levels.
 - ✓ Indoor seating at taverns is not allowed; customers may enter taverns only to order, pick-up, and pay for food or beverage.

Membership:

- o Thru January 2021 we had 394 total members on 258 total memberships:
 - ✓ 86 complimentary members on 56 memberships
 - ✓ 21 early 2019 members on 11 memberships
 - ✓ 287 regular members on 191 regular memberships
- Thru January 2020 we had 392 total members on 260 total memberships:
 - ✓ 78 complimentary members on 53 memberships

- ✓ 35 early 2018 members on 23 memberships
- ✓ 279 regular members on 184 regular memberships
- Notify Blackhawk members of the board's decision to forgive any unworked hours during 2020 Brian Kreutz
- o Review & discuss the current Blackhawk membership fees.
 - ✓ No change in membership fees is recommended.
 - ✓ Recommend talking about annual membership fees at the September meeting.

- List of projects/ideas for 2021
 - ✓ Jeff Button suggested a back stop is needed on a target shooting toward the Ice Age Trail
 - Continuing to work on this
 - ✓ A back stop is needed at the end of the 1st 80-yard NFAA target
 - > Space is being cleared out for the construction of this
 - > Rock pile is a deterrent, will not be able to dig into it; but continuing to work on this
 - ✓ Jon plans to build a platform stand in the broadhead shooting area
 - Revisit in spring
 - ✓ Replace boards on picnic tables
 - ➤ All but 2 tables have been leaned up against the shed to prevent rot from snow
 - ➤ Have some bases, will replace in spring
 - ✔ Relocate some bow hangers
 - Revisit in spring
 - ✔ Replace outdoor range targets
 - Was not able to complete this due to Covid-19; will revisit in spring
 - ✓ Schedule a club cleaning Alan Riggs sweeping has been done; no deep clean needed
 - ✓ Need to fix lock to storage door
 - ✓ Clean weeds out of broadhead bunkers
 - Area looks clean; will revisit again in spring

• Tournaments:

- o Indoor Brush Shoot scheduled for March 6&7, 2021 has been cancelled.
 - ✓ Not able to hold due to Dane County Covid-19 restrictions

Old Business:

- o Construct a fence along the Blackhawk/Ice Age Trail property line
 - ✓ The low bidder was Stone Edge Landscaping at a cost of \$12,409
 - > The board formally approved the expenditure via a Survey Monkey vote on Jan. 13, 2021
 - Adding a gate to the fence has increased the cost by \$300
 - > Construction will begin in the spring
 - > \$4136.30 deposit has been mailed; proposal has been signed
 - > Contractor will obtain the building permit
 - ✓ The fence will be constructed on the property line
 - Jon Dove will contact Dan Frick to investigate the cost of having the north property line officially surveyed
 - Dan cannot survey due to conflict with his work position
 - Company in New Glarus was recommended Jon sent a message & is waiting to hear back with further information
- Investigate moving the club to a new location with more acreage and a less restrictive environment. The relator has not found anything in Dane County that meets our needs or price range. He will keep looking.
- o The Blackhawk raffle was delayed until the spring due to Covid Dannielle
- No further discussion

• New Business:

- o Proposal to teach private archery lessons at Blackhawk Alex Yant
 - ✓ Member for a little of a year
 - ✓ Has level 2 archery certification; knows how to teach safely & effectively
 - ✓ Has private insurance to cover his lessons
 - ✓ Is a recurve shooter; however also familiar with compound
 - ✓ Wants to increase knowledge and interest into archery; hoping to increase membership
 - ✓ Would like to charge \$30/hour for lessons
 - > No more than three one hour-long lessons a week
 - Lessons would be typically Mon-Fri; would work around Blackhawk's schedule
 - Lessons would be 1:1
 - > Offers a recurve to use or student would bring own equipment
 - ✓ Club would not have to be shut down, other members welcome to utilize club
 - ✓ Jason made motion to approve; motion seconded by Alan; motion approved
 - Alex will place \$1 per target used in the target box
 - ➤ If seeming to enjoy the sport, encourage to join as a member give further information

- > Dale will email Alex with board decision
- o Update on the new 3D targets purchased in January Jerry Gleisner
 - ✓ 23 new 3d targets, blem sale from Rinehart, purchased for \$4700.00; typically run \$6700.00
 - ✔ All have arrived and placed in target shed
 - ✓ Recommend placing old targets outside of the shed in the spring & sending 'first come first serve' communication out to members
