 - Approximately \$33k increase from May 2024
 - Largest Expenses:
 - Supplies (2x4s, Door, Target, Mower)
 - Electricity, Internet/TV/Phone, Waste pickup
 - Amy made a motion to approve Treasurer's report; seconded by Roger; motion approved
- Grants (DNR)
 - 2024: 5 additional wooden walls on outside 3D course (DONE); second handrail for ADA stand; concrete paths to outdoor shooting areas - APPROVED
 - 2025 Grant: ADA compliant doors, two entrance doors and two bathrooms, 2 bridges, 20 block targets/3D targets (\$8,000) – APPROVED

- **MEMBERSHIP**

- Status Update
 - May 2025
 - 337 total members on 211 total memberships
 - 56 complimentary members on 37 memberships
 - 281 regular members on 174 regular memberships
 - May 2024
 - 364 total members on 202 total memberships
 - 64 complimentary members on 40 memberships

 - Invoices have been mailed to all members with outstanding work hours from 2024
